

REQUIREMENTS TO CONDUCT CLINICAL RESEARCH PROJECTS IN THE UNIVERSITY HOSPITAL DOCE DE OCTUBRE

Promotors/investigators wishing to conduct a clinical research project in the University Hospital Doce de Octubre should have an approval of an accredited Ethic Committee of Investigation (CEI) in Spain.

Two procedures are possible depending on the study is approved or not by other CEI

1) ASSESMENT NEW PROJECTS (WITHOUT REC APPROVAL)

The submission should be by mail (ceicdoc@h12o.es), the following documentation is required

- A. **Full protocol** (accepted in English, dated and versioned) **and Protocol summary** (Spanish)
- B. **Informed Consent Form** (in Spanish), identified with date and version number
- C. Principal Investigator's commitment signed and curriculum vitae
- D. Sub-investigator's commitment signed and curriculum vitae (if applicable).
- E. Chief (or Responsible) Department acceptance
- F. Economic Budget detailing: scheduled payments to the principal investigator and to participants (if it is applicable)

En este documento se deberán recoger las cantidades y el modo en que los investigadores y sujetos puedan ser, en su caso, remunerados o indemnizados por su participación en el estudio, así como los elementos pertinentes de todo contrato previsto entre el promotor y el centro.

- G. **Insurance policy** including the names of Hospital, Principal Investigator and Hospital Doce de Octubre Foundation for Biomedical Research

*If a **major amendment is submitted to assess**, besides on modified documents (with tracked changes), a cover letter summarising and justifying the changes should be submitted

In the cases of:

- 1) Projects submitted to calls for public or private funding through Hospital Doce de Octubre,
- 2) Academic work

Prior to submission to the CEI, the Hospital Research Commission's Evaluation Report is required, which should be requested through: National and International Projects Processing / Project Management Area. Research Management (email: fvalero.imas12@h12o.es). Once assessed by this Committee, if CEI evaluation is required, they will be forwarded by this Management Area to the CE

2) NOTIFICATION OF PROJECTS AUTHORIZED BY OTHER ETHIC COMMITTEE

In these cases, the CEIm recognizes the approval and the study will not be again evaluated. The CEI technical office assesses the local viability and a report will be done. The documentation indicated in point 1 was sent by mail (stecnicacei@h12o.es), except for the B. Informed Consent Form, and a copy of the **Favorable Report issued by the CEIm that evaluated the study**. The protocol can be replaced by the Summary of the same. In addition, it should be indicated in a separate document, which is the implication of the researchers of our center (obtaining biological samples with prospective character or that are stored in the biobank of the center, analysis of samples...)
